## INTRODUCTION

FXTM<sup>1</sup> is organizing “2024 Trade Olympics Contest” (hereinafter the “Contest”) and invites all new and existing Clients to register and/or participate in the Contest.

By participating in this Contest, a contestant (hereinafter the “Contestant” or the “Client”) agrees to be bound by the Terms and Conditions herein (hereinafter the “Terms”) and the Operative Agreements.

## 1. INTERPRETATION OF TERMS

### 1.1. In this Contest:

**“Account”** shall mean a Client’s trading account with FXTM which the Client deposited with Contest Minimum Deposit after accepting the current Terms;

**“Contest Period”** shall be from the 15<sup>th</sup> of July 2024 (00:01) till the 23<sup>rd</sup> of August 2024 (24:00) (inclusive). Times mentioned herein shall mean EEST as applicable. FXTM reserves the right to extend the period of Promotion at its own discretion;

**“Client”** shall mean a person who has completed the “Complete your Profile” Form within MyFXTM and/or the “Corporate Trading Account Application Form” or any other method designated by FXTM, has read and accepted the Operative Agreements and relevant identity checks have been completed to FXTM’s satisfaction.

## 引言

FXTM 富拓<sup>1</sup>舉辦“富拓奧林匹克交易賽”（下稱“比賽”），邀請本公司所有現有客戶和新客戶報名參加。

參加本次比賽即表示參賽選手（下稱“參賽選手”或“客戶”）同意受以下條例和條款（下稱“條款”）和操作協議約束。

### 1. 術語釋義

在本次比賽中：

**“帳戶”**：指客戶的 FXTM 富拓交易賬戶，在接受本條款後，存入比賽要求的最低入金額；

**“比賽期”**：從 2024 年 7 月 15 日(00:01)至 2024 年 8 月 23 日(24:00)(包含括號中時間)。本協議中提及的時間為東歐夏令時間。FXTM 富拓保留自行決定延長活動期的權利；

**“客戶”**：已在 MyFXTM 或 FXTM 富拓指定的任何其他方法完成“填寫您的個人資料”表格和/或“公司交易賬戶申請表”，並已閱讀和接受操作協議且已按富拓的要求完成身份核查的人士。

FXTM 富拓指在 FXTM 富拓品牌運營下的 Exinity Limited（詳見 <https://www.futuo-guoji.com/zh>），受毛裡求斯金融服務委員會監管。

**“Existing Clients”** shall mean a person who became a Client before the Contest Registration Period.

**“現有客戶”：**在本次比賽報名期前成為 FXTM 富拓客戶的人士。

**“New Client”** shall mean a person who became a Client during the Contest Registration Period.

**“新客戶”：**在比賽報名期內成為 FXTM 富拓客戶的人士。

**“Contest Minimum Deposit”** shall mean a deposit in the Account of an amount equal to or in excess of \$200 or its equivalent.

**“比賽最低入金”：**賬戶中的入金額等於或超過 200 美元或其他等值貨幣。

**“Minimum Notional Volume”** shall mean an eligible notional volume in excess of \$1,000,000 or its equivalent in the Contest Period.

**“最低合約名義價值交易量”：**客戶在比賽期間需要完成最低 1,000,000 美元的合資格合約名義價值交易量

**“Operative Agreements”** shall mean the agreements entered into by the Client and FXTM that govern all trading activity of the Client with FXTM. Operative Agreements consist of the Client Agreement, Policies and Terms of Business, as these may be found in the Operative Agreements section of the Website of FXTM and as may be amended from time to time.

**“操作協議”：**客戶與 FXTM 富拓達成的規範客戶在 FXTM 富拓所有交易活動的協議。操作協議包括客戶協議、政策和商業條款，這些都可在 FXTM 富拓網站開戶協議專區查看並且不定期修訂。

**“Prizes”** shall mean the prizes as defined in the Table 1 in the Clause 5.1 k) herein.

**“獎金和獎品”：**獎品參見以下 5.1 k)條中表 1。

**“Profit Calculation Formula”** shall mean the profit calculation formula as provided in the Clause 4.6. below.

**“利潤計算公式”：**利潤計算公式見以下第 4.6 條。

**“Contest Registration Period”** shall be from the 1<sup>st</sup> of July 2024 (00:01) till the 23<sup>rd</sup> of August 2024 (24:00) (inclusive)

**“比賽報名期”：**從 2024年7月1日(00:01)至2024年8月23日(24:00)(包含括號中時間)。

**1.2.** Any words whose meaning is not defined herein shall have the meaning provided in the Operative Agreement.

任何未作釋意的術語其定義請參見操作協議。

**1.3.** Times mentioned herein shall mean EEST as applicable.

本協議中提及的時間為東歐夏令時間。

## 2. ELIGIBILITY CRITERIA

### 資格標準

**2.1.** To participate and become a Contestant in the Contest, you must meet the following requirements:

參加並成為本次比賽的參賽選手，您必須符合以下條件：

a) You are a new or existing Client of FXTM, eligible to trade in accordance with, and have agreed to, the Operative Agreements;

您是 FXTM 富拓新客戶或現有客戶，根據且已同意的操作協議有資格交易；



- b) You run a Live trading account with FXTM as per the applicable account minimum deposit and/or other requirements of FXTM;
- c) You have registered for the participation in the Contest and agreed to these Terms during the Registration Period;
- d) You have deposited a "Contest Minimum Deposit" within the Contest Period;
- e) "One prize per person" rule means that only one Prize (according to Table 1 below) can be won per person over the entire Contest period, not applicable to Table 2 & Table 3

依據適用的賬戶最低入金額和/或 FXTM 富拓的其他要求，您已在 FXTM 富拓開設真實交易賬戶；

您已報名參加本次比賽並在報名期內同意本條款。

您已在比賽期內存入“比賽最低要求入金額”；

“每人一獎”規則是指在整個比賽期間，每人只能獲得一個獎項(如下表 1 所示)，表格 2 和表格 3 獎品不適用。

### 3. TRADING TERMS

- 3.1. The Contest is applicable to all FXTM Spot Indices, Stocks & Stock CFDs, Cryptocurrency and Commodities. Forex, XAUEUR and XAUUSD are not applicable to the contest trading requirements.
- 3.2. The Contest is applicable to the following accounts Classic Advantage MT4/MT5, Advantage MT4/MT5 and Advantage Plus MT4/MT5 only.

### 交易條款

本次比賽僅適用於富拓現貨指數、股票及股票 CFD、大宗商品和加密貨幣產品。貨幣對及黃金產品不適用於此次比賽。

本次比賽適用於以下賬戶類型：經典超低點差賬戶 MT4/MT5、超低點差賬戶 MT4/MT5、0 億金賬戶 MT4/MT5。

### 4. SPECIFIC CONTEST TERMS

- 4.1. Each Contestant is allowed to participate in the Contest with only one Account entry.
- 4.2. Each Contestant is allowed to participate in only one contest run by the FXTM at the same time.
- 4.3. Withdrawal requests shall be processed normally during the Contest Period, subject to the Contestant meeting standard requirements set out in the Operative Agreements.
- 4.4. Transfer(s) of the funds between the accounts are not considered as Contest minimum deposit(s) for the purposes of this Contest.

### 特別比賽條款

每位參賽選手只允許用一個賬戶參加比賽。

在比賽期間，每位參賽選手只可參加由 FXTM 富拓舉辦的一項比賽。

在比賽期間，如參賽選手符合操作協議所規定的標準要求，出金申請可正常處理。

賬戶之間資金轉賬不被視為用於本次比賽的最低入金。

- 4.5.** Upon commencement of the Contest Period, the Contestants can trade normally. When determining the winners of the Contest, these trades made within the Contest Period will be considered as per the Profit Calculation Formula set out in Clause 4.6. below.

#### “Profit Calculation Formula”

- 4.6.** Subject to the Clause 5.1 below, the winners of the Contest will be the Contestants who, in accordance with the Profit Calculation Formula, have the highest profits in the absolute number at 23:59:59 server time on the last day of the relevant Contest Period, out of the total pool of the Contestants. In a Profit Calculation Formula will be included only traded Standard Lots. The Profit Calculation Formula is:

Total Net Deposit During the Competition	Formula
≤ USD\$10,000	<b>Score =</b> <b>Cumulated trading net trading profit during the competition</b>
>USD\$10,000	<b>Score =</b> <b>Cumulated trading net profit during the competition / (Total Net Deposit amount / 10,000)</b>

- 4.7.** For the purposes of the Profit Calculation Formula:

- “**Deposit(s)**” shall, subject to the para 4.11. below, mean all the Deposits made in the Account during the Contest Period following the acceptance of the Terms and the Contest Minimum Deposit required to enter this Contest.
- “**Net Trading Profit**” shall mean the actual profit and loss of the accumulated performance in the Contestant's Account during the competition period, if any.

比賽開始後，參賽選手可正常交易。比賽獲勝者將按第 4.6 條所列的利潤計算公式來確定。

#### “利潤計算公式”

根據以下第 5.1 條，本次比賽的獲勝者是在相應比賽期最後一天服務器時間 23:59:59，在全體參賽選手中根據利潤計算公式，計算得出淨利潤最高的選手。利潤計算公式中只包含已完成的標準手交易。利潤計算公式為：

在利潤計算公式中：

“**入金**”：根據以下第 4.111 條，指參賽選手在接受本條款後，在比賽期內完成的全部比賽最低入金。

“**累計交易淨利潤**”：在比賽期內參賽選手賬戶中的累績實際損益利潤。



- “**Total Net Deposit**” shall mean the difference between the total deposit and total withdraws during the Contest Period in accordance with Clause 1.1 above.
- 4.8.** In calculating Profit, all open positions in the Contestant's Account, as of 23:59:59 server time on the 23<sup>rd</sup> of August 2024 shall be considered at the last quoted price on the relevant FXTM Trading Platform. Calculation shall be finalized within 12 hours from the closing of the last completion day.

Short Positions will be calculated using the Ask Price and Long positions will be calculated using the Bid Price.

The following positions are not eligible for the Contest:

- positions that are opened before the Contest period and closed during Contest period;
- positions that are opened before the Contest period and are still open at 23:59:59 server time on the 23<sup>rd</sup> of August 2024.

- 4.9.** FXTM will maintain during the Contest Period a weekly leader board recording the Contestant's indicative Profit & Loss standing on website.

#### “Option to Reset”

**4.10.** The Contestant shall, at any time during the Contest Period, have the right to reset his/her current Profit & Loss standing (“Option to Reset”). It is understood that following the exercise of the Option to Reset:

- a) Subject to (b) below, the Profit & Loss shall be considered for the purposes of this Contest as 0;
- b) The Contestant may, during the Contest Period, re-enter the Contest afresh provided that he/she re-deposits in the Account a new Contest Minimum Deposit;
- c) The Terms of this Contest continue to apply.

“總淨入金額”：指參賽選手在比賽期內根據以上條款 1.1 規定的活動期間的總入金和總出金之間的差值。

在計算利潤時，參賽選手賬戶截至服務器時間 2024 年 8 月 23 日 23:59:59 所有未平倉倉位按相關 FXTM 富拓交易平台的最後報價計算。利潤計算應在最後一個比賽日收盤後的 12 個小時內完成。

空單使用買價計算，多單使用賣價計算。

以下倉位不符合參賽資格：

- 比賽期前開倉，在比賽期內平倉；
- 在比賽期前開倉，且在服務器時間 2024 年 8 月 23 日 23:59:59 依舊開倉。

在比賽期間，FXTM 富拓將在網站上發布每週排行榜，記錄參賽選手的交易淨利潤排名。

#### “重置選項”

參賽選手在比賽期內有權隨時重置他/她的當前利潤狀態（“重置選項”）。據了解，在行使重新選項後：

根據以下(b)條，參加本次比賽的交易淨利潤應為 0；

參賽選手在比賽期內可重新參加比賽，但他/她需在賬戶中重新存入新的最低入金額；

本次比賽條款繼續適用。

**4.11. In the event the Contestant re-enters the Contest, following an Option to Reset:**

- a) For the purposes of the Profit Calculation Formula, Deposit(s) shall mean deposits made in the Account during the Contest Period following a new Contest Minimum Deposit, after using option to reset, as per the Clause 4.10 b) above.
- b) For the purposes of calculating the Profit, only the Closed Positions that are closed following the new Contest Minimum Deposit as per the Clause 4.10. b) above, shall be considered.

如果參賽者在行使重置選項後重新參加比賽：

在利潤計算公式中，入金指在該參賽選手根據以上 4.10(b)使用重置選項存入新的最低入金後，在比賽期內存入的資金。

在計算利潤時，只有根據以上 4.10(b)存入新的最低入金後平倉的倉位會被考慮在內。

**Example 1:**

On the 17<sup>th</sup> of July 2024 Mr. FXTM Contestant enters the Contest in accordance with the Terms. Following the first Profit Review, the Profit for the Account is calculated at 200. Mr. FXTM Contestant continues to trade and on the 30<sup>th</sup> of July 2024 his Profit score reaches 280.

On the 2<sup>nd</sup> of August 2024, the Contestant's Profit becomes negative; Mr. FXTM Contestant decides to exercise the reset option and re-enter the Contest. The Contestant makes a new Contest Minimum Deposit in the Account and re-enters the Contest with a starting Profit at 0. Mr. FXTM Contestant starts his trading activity afresh until the end of the Contest Period.

**舉例 1**

2024 年 7 月 17 日，FXTM 富拓參賽選手根據條款參加比賽。在第一次利潤評估後，他的賬戶利潤為 200。該參賽選手繼續交易，2024 年 7 月 30 日，他的利潤達到 280。

2024 年 8 月 2 日，該參賽選手的利潤百分比變為負值，他決定行使重置選項並重新參賽。該選手在賬戶中重新存入最低入金額並重新參加比賽，他的初始利潤為 0。該選手重新開始他的交易活動，直到比賽期結束。

## 5. CONTEST PRIZES

### 5.1. The Prizes:

- a) The Prizes that are available for distribution are set out in the Table 1 below.

#### b) Weekly Lucky Winners

FXTM randomly selects one eligible Contestant on a weekly basis, the selected Contestant will be entitled to receive the prize of Weekly Lucky

Winners in accordance with the Table 2, notwithstanding the Clients TOP ranking: on the 19<sup>th</sup> of July 2024, 26<sup>th</sup> of July 2024, 2<sup>nd</sup> of August 2024, 9<sup>th</sup> of August 2024, 16<sup>th</sup> of August, 23<sup>rd</sup> of August 2024 the 23:59 server time.

### c) Weekly Special Random prize

FXTM randomly select another eligible Contestant on a weekly basis, the selected Contestant will be entitled to receive the Weekly Special Random prize in accordance with the Table 3, notwithstanding the Clients TOP ranking: on the 19<sup>th</sup> of July 2024, 26<sup>th</sup> of July 2024, 2<sup>nd</sup> of August 2024, 9<sup>th</sup> of August 2024, 16<sup>th</sup> of August 2024, 23<sup>rd</sup> of August 2024 the 23:59 server time.

- d) Regarding to the eligibility of **Weekly Lucky Winners** and **Weekly Special Random Prize**, Contestants need to meet the following conditions to participate in the weekly lucky draw, and each Contestant is only entitled to one chance of winning.
- Net Deposit over USD\$200 during Contest Period;
  - Notional Volume over USD\$1,000,000 during Contest Period
  - Regarding to Prize redemption of **Weekly Luck Winners**, FXTM will announce the winner via FXTM Official Website within 5 working days of the completion of the lucky draw.
  - For Greater China region contestants, regarding to Prize redemption of **Weekly Special Random Prize**, FXTM will notify the winner via FXTM LINE Account within 5 working days of the completion of the lucky draw. The winner must redeem the prize before 2<sup>nd</sup> of August 2024, 16<sup>th</sup> of August 2024, 23<sup>rd</sup> of August 2024, 3<sup>rd</sup> of August 2024 and 6<sup>th</sup> of

September 2024. Winner who do not confirm the Prize collection and provide the required information for Prize collection will forfeit the prize without being compensated. FXTM will not be responsible and re-issue for damaged, lost, stolen or expired prize that have already been collected by the winner.

- e) Upon commencement of the Contest in accordance with the Clause 4.6, the winners will be announced and entitled prizes in accordance with Table 1.
- f) In the event that two or more Contestants have the same Profit & Loss (to the second decimal point), then the Contestant with the higher notional volume will be higher in the rank. Whereas there are still two or more Contestants with the same result, and those Contestants are both entitled to a Prize, then the Prize will be shared equally between these Contestants.
- g) The final 10 winners must complete the required notional volume corresponding to the prize tier of their p&L ranking. In the event that a contestant did not fulfill the required notional volume, the client cannot win the prize of that tier, and will be downgrade to the tier of which notional volume he fulfilled.
- h) Within 15 days after the end of the Contest, the eligible winners will be notified by an e-mail – to the email address they have specified during the registration – accordingly (hereinafter the "Notice").
- i) The Prizes shall be awarded only to the Clients with the status "Approved", meeting standard requirements as per the Operative Agreements.
- j) In case an eligible winner fails to provide such documents as deemed necessary by FXTM within a 5 Business-Days' notice, the Prize shall be cancelled.

  - m) The Prizes is only applicable to eligible trades, which are not applicable to all forex pairs and XAUUSD. One trade refers to a complete round trip of opening and closing a position. Only positions opened and closed for more than 5 minutes are considered eligible.
- 5.2.** The Weekly Prizes indicated in the Table 1 will be awarded to the Winners or could be delivered via post.

## 6. MISCELLANEOUS

### 6.1. FXTM has the right to disqualify any Contestant if:

- a) a breach of these Terms and/or any term of the Operative Agreement occurs;
- b) FXTM has a reasonable ground to believe a misuse of the Contest;
- c) the Contestant acts in bad faith and/or abusively and/or fraudulently and/or in a manner that is not in the spirit of the Contest.

### 6.2. Each Contestant hereby expressly consents that FXTM:

- a) may publicly announce their name and details of their participation in the Contest on the Websites or any other publication (electronic or not);

- b) use a photo of the Contestant in any appropriate manner and publication that FXTM decides to use, without any recourse or compensation, and that the Contestant surrenders and waives all copyright and intellectual property rights to the use of such a photo in relation to the Contest or FXTM's promotional activity;
  - c) may conduct an interview with the Contestant and use said interview in any publication as they wish in relation to the Contest or FXTM's promotional activity.
- 6.3.** In the event of any dispute or misinterpretation of the above applicable Terms, such dispute or misinterpretation shall be resolved by FXTM, acting in good faith and as it shall, in its sole and absolute discretion, deem fit and proper. FXTM's decision shall be final and binding.
- 6.4.** FXTM reserve the right, as it is in their sole discretion deems fit, to alter, amend, suspend, cancel or terminate this Contest, or any aspect of the Contest at any time, subject to giving you prior notice. Under no circumstances shall FXTM be liable for any consequences of any alteration, amendment, suspension, cancelation or termination of the Contest.
- 6.5.** Any indication or suspicion of fraud, manipulation, cash-back or bonus or swap arbitrage, or other forms of deceitful or fraudulent activity in a client's account or multiple account with FXTM or otherwise related or connected to the Prize will nullify any and all transactions executed and/or profits or losses garnered therein.
- 6.6.** Notwithstanding the translated language of this document, the English wording shall be the binding version in the event of any discrepancy between the two languages.
